About Workshop

Technological advancements in healthcare have revolutionized society, particularly in the area of continuous health status monitoring using Wireless Body Area Networks (WBANs). Cloud technology can efficiently manage resources used in WBANs, enabling medical service providers (MSPs) and WBANs to analyze physiological parameters. However, there are potential security and privacy implications that discourage users from adopting smart healthcare technology. Trusted Third Party (TTP) can easily track the medical activity of a user, potentially leading to malicious activities and threats to their life. Additionally, the centralized system relies on TTP, which can lead to system failure and the sale of medical data without proper consent. The aim of this workshop is to spreding the knowledge in this direction as well as in the relevant direction of research in the areas of security and privacy. Experts from IITs and IIITs will deliver the talks in this workshop to share their knowledges and experties.
