- 2. **Validity of Quotation:** Quoted rate must be valid for 45 days from the last date of submission of quotation.
- 3. **Delivery and Installation:** The successful bidder shall complete delivery/supply and installation within 20 days. Delivery/installation site is: IIITG Boys'/Girls Hostel, IIIT Guwahati, Bongora, Guwahati 781015. Installation site(s) may be visited by the intending bidders in any working day during office hours.
- 4. **Actual Quantity** at the time of order may slightly vary. Bidder should therefore mention the rates per feet/item specifically.
- 5. **Warranty:** 1(one) year onsite warranty.
- 6. **Experience Criteria:-** The bidder has to have minimum 2 years of experience in supply & installation of Exhaust/Ducting system.

7. Quotations should be addressed and submitted to "The Associate Dean(R&D), Indian Institute of Information Technology Guwahati (IIITG), Bongora, Guwahati-781015" in a sealed envelope superscribed with "IQ No: IIITG/S&P/2021/215/78 dt 04.02.2022) so as to reach us on or before 10-02-2022 upto 1400 Hrs.

Along with the quotation, following documents are to be submitted: -

- c) Bank account details.
- d) Copy of Experience certificate(s)/Purchase order(s) in support of 2 years of experience in supply & installation of Exhaust/Ducting system.
- 8. **Payment:** 100% Payment within 30 days from the date of successful supply & installation.
- 9. **Termination for default: -** Default is said to have occurred
  - a) If the supplier fails to deliver any or all the items within the time period(s) specified in the purchase order or any extension thereof granted by IIIT.
  - b) If the supplier fails to perform any other obligation(s) under the contract.
  - c) Under the above circumstances the Competent Authority, IIIT may terminate the contract / purchase order in whole or in part or any other penalty as deemed fit.

## 10. Applicable Law:

- a) The contract shall be governed by the laws and procedures established by Govt. of India and subject to exclusive jurisdiction of Competent Court and Forum in Guwahati only.
- b) Any dispute arising out of this purchase shall be referred to the Director IIIT Guwahati, and if either of the parties hereto is dissatisfied with the decision, the dispute shall be referred to the decision of an Arbitrator, who should be acceptable to both the parties, to be appointed by the Director of the Institute. The decision of such Arbitrator shall be final and binding on both the parties.
