# <u>Item No. 1</u> Minutes of the Fortieth Meeting of the Board of Governors of the Institute held on 04/10/2023

**Resolution 41.1:** The Minutes of the Fortieth meeting of the Board held on 4<sup>th</sup> of October 2023, were approved.

### Item No. 4 Senate Nominees to the Re-Constituted Board

# Item No. 5 Creation of Non-Faculty Posts.

The Board agreed to the need to hire more staff in light of the increase in the number of students. It approved the proposal to release some posts and to add some posts. It also approved the recruitment of 8 persons at the level of Junior Assistant.

# Item No. 6 Recruitment Rules for Non-faculty

The Board noted that revision of the recruitment rules for non-faculty posts was placed before the Board in its 23rd meeting held on 9th August 2019. However, the item was deferred due to the need of including provisions of promotions. A promotion policy was approved by the Board in its 27th meeting held on 24.09.2020. However, the revised recruitment rules have not yet been approved by the Board. The Board agreed with the revised recruitment rules and approved them.

**Resolution 41.7:** The Board resolved to defer the formation of this Committee till the Board of the Institute is re-constituted.

# <u>Item No. 8</u> Appeal by Students against the Punishments Awarded on Disciplinary Grounds

The Board examined the matter. The Board noted that one of the students awarded a punishment of a semester drop had appealed to the Board for removal of this punishment. The Board noted the recommendations of the Institute Student Disciplinary Committee (ISDC) to this appeal and agreed to remove this punishment for both the students.

**Resolution 41.8:** The Board resolved to remove the punishment of a semester drop awarded to Shivam Dwivedi and Ashutosh Rai. The Board further resolved that the punishments to be awarded to these two students are to be decided by the ISDC.

## Item no 9: Enhancement of Dearness Allowance (DA) from 42% to 46%.

# <u>Item no 14: (Additional Item 1)</u>: Matter Arising out of Audit Observation Regarding Institute's Contributions to Employees' Pension Scheme under the New Pension Scheme

The Board examined the matter. It agreed with the decision taken not to enhance the Institute's contribution to the new pension scheme from 10% to 14% from 1/4/2019 in view of the shortage of funds. It noted that the financial situation has now improved and approved the increase of the contribution with effect from 01/01/2024.

**Resolution 41.14:** The Board resolved to approve the enhancement of Institute's contribution to employees' New Pension Scheme to 14% of the Basic pay and dearness allowance, with the employees' contribution being 10%, with effect from 01.01.2024. The Board also ratified the decision of the Institute not to implement this increase from 01/04/2019 till 31/12/2023 due to financial constraints
