No. 2: BWC:

The Committee noted the Actions taken report as placed before it.

Item Status of Construction Works in the permanent campus:

No. 3:

The committee was apprised about the current status of the classroom vertical expansion. The committee advised that the work should be get completed before the next Academic session. The committee also noted the completion/progress of minor/misc. works in the campus.

Item Allotment of work for "Developing a lawn in front of Academic cum Admin No.4:

Building at Indian Institute of Information Technology Guwahati"

The committee examined the evaluation reports as placed before it. The committee found that to be in order.

Therefore, the committee accepted the recommendations of the evaluation committee & decided to award the work to the qualifying bidder M/s Daffodil Nursery Old at his quoted price of Rs.22,01,000/-

**Tendering for remaining work of Sports Ground & Courts:** Item

No.5:

The committee noted the status of work done by the earlier contractor M/s Girdhari Lal and Sons Sports Pvt. Ltd and the remaining works for completion. Accordingly, tender value for remaining work will be Rs.82.73 Lakh (say Rs.

83 Lakh)

The committee examined the draft tender/eligibilities as placed before it and having found it in order, approved the same for tendering.

Item **Tender for a new Architect Consultant for proposed Phase 2 works:** 

No.6:

The committee was apprised about the necessity for going for a new Architect Consultant. The committee examined the draft tender as placed before it and having found the same in order, approved it for tendering.

## Item To Consider a proposal for earth filling in some priority area to create No.7: new infrastructures (Phase 2):

The committee was apprised about the reasons for going for earth filling in some priority area during the current dry season itself. Further, the rationality behind proposed execution through State PWD (Rd.) deptt, who had been doing campus earth filling in the Institute since its inception.

The committee considered the estimates submitted by PWD (Rd.) and decided to approve the same at a total estimated cost of Rs. 143.26 Lakh. The committee further decided to recommend to board for Administrative approval of Rs.158 Lakh (10% more than the said estimated amount)

# Item Proposal of constructing paved surface for the rear road of Academic No.8: Building to Boys Hostel:

The committee was apprised about the necessity for making the surface paved for the road in subject.

The committee noted the fact that this road paving work must be completed during this current dry spell so as to provide the students a smooth useable road surface before start of any rains. The committee **agreed to the estimate**, which was based on DSR-21 & PWD SOR-21 for one item.

Since, there is an **urgency** for completing the work by the current dry spell itself, the committee explored possibility of executing the work with a contractor working in the campus. It was found that M/s Abdul Quddus who has just completed the similar work of periphery road of SAC building/Town hall with a scheduled rate (without any escalations). Hence, it was decided by BWC to execute the work through the same contractor at the estimated rate & accordingly **approved the said allotment to M/s Abdul Quddus** as priority work and as deviation to his SAC Building work. Further, the contractor will be given one-month time extension for this work.

## Item In-principle approval for some Misc. works: No.9:

The committee noted the necessity for the proposed works and having found those in order, decided to accord in-principle approval for the said works @ preliminary cost estimated amounts mentioned alongside.
