1	Table	Pramework: The 'C' Frame assemblies must be manufactured from standard hollow metal sections; conforming to IS standard and all sheet metal components should be of CRCA conforming to IS standard. The Framework is basically made of Rectangular hollow tubes with a cross section of 50mm x 25mm and should be 2mm thick and must be without a vertical front leg to give a clean look. This shall provide more knee space and would facilitate uninterrupted lateral movement. The C-Frame legs should be provided with adjustable feet to correct the unevenness of flooring. The tubular enclosed type construction shall discourage dust accumulation. The height of the modesty Panel must be minimum 400mm. The modesty panel must be installed on threaded metal inserts for durability of the mounting system and ease of maintenance.  Static Load Capacity: One Hundred and Fifty kilograms.  Table top: 25mm thick Pre-laminated particle board conforming to IS standard (Make: Century / Equivalent) with 0.8/1.5 mm thick using PVC edge bend (Make: Rehau or equivalent). One PVC wire manager grommet hole shall be provided on the worktop.  Accesory: One Metal powder coated CPU Stand with twin wheel Castors with each Table. Metal powder coated CPU Stand with 4 castor wheels, which are lockable. Load carrying capacity around 50 kgs. It must be manufactured in high grade sheet metal steel. CPU stand must be separable from the modular desk.  All metallic structures must be rust-proof and must be durable for 7 years, which must endorsed by OEM warrantee. All equivalents and color scheme of the product must be approved by the institute.
