#### 1. INTRODUCTION

The Institute was established as a Society in 2013 and the first batch of students were admitted in August 2013, classes commenced on August 26 2013. The Institute has been established in not-for-profit public-private partnership (NP-PPP) mode. The Central Govt. is to contribute 57.5% of the capital expenditure, the Assam State Govt, 35%, and industry partners 7.5%. An MOU among the Stake holders and Rules of the Society, govern the functioning of the Institute.

The second batch of UG students joined the Institute in August 2014. A PhD programme was started in January 2015. Faculty and Staff recruitments took place during the year. There were 118 UG students and 5 PhD students as of March 31 2015.

Classes and the office continued to function from two floors of a building in the campus of the Assam Textile Institute, GNB Road, Guwahati.

Students and faculty stayed in hired flats in Shine Heavean Flat Complex, Baghorbori, Guwahati. 32 flats were taken on lease in the complex.

70 acres of land in Sontola, Guwahati, about 4 km from the airport was handed over to the Institute on October 30 2014

M/S Hindustan Prefab Ltd, New Delhi were appointed, on nomination basis, as the Project Management Consultants. M/S Mriduanjali Ltd, Noida, were appointed the architects for the first phase of construction through a tendering process.

### 10. CAMPUS

The Government of Assam handed over 200 bighas (about 70 acres) of land for the campus of the Institute in Bongora and Sontola villages in Kamrup (rural) district. The site is next to the proposed IT Park of the Govt. of Assam. It is about 4 km from the airport. The Master Plan for the campus was prepared by the Architect and it is enclosed at Appendix 1. Phase I of the construction plan envisages the following major buildings:

- 1. Academic-cum-Administration Building
- 2. 400 seater Boys' Hostel
- 100 seater Girls' Hostel
- 4. 48 Faculty residence flats
- 5. Utilities Electrical, Power, Sewerage.

Construction is planned to begin at the end of the monsoon season, in October – November 2015.


